October 24, 2022

- I. Meeting Called to order at 6:00 p.m., the pledge of allegiance was recited by all
- II. Roll Call taken, , Jan Waltz, Kathy Jernigan , Ray Wlosinski, John Sutter , Vijay Kumar(exc), Tina Carpenter, Shirley Karch and Vickie Smith.
- III. Additions to agenda—New Business: pizza fundraiser, Justin Plunkett Grant for Banner Poles for over the road

- V. There was a motion by Kathy Jernigan to approve Sept. minutes and seconded by Jan Waltz. Motion passed
