

RESERVATIONS

1. Campground is open April 1 to Dec 1, and is closed for winter months. Campground opens for reservations on January 3rd. Call (989) 389-4452 for reservations.
2. Reservations may be made by phone or in person for Modern and Rustic campgrounds. Total charges must be received by us within two weeks after making reservations or the site will be reopened. A reservation will be given or sent to you when the site rent is paid.
3. Limited seasonal Modern and Rustic Sites are available. All sites are FCFS and total charges must be received by April 30th.
4. On Holidays and Holiday weekends, we will accept reservations for a minimum of three nights in Modern and Rustic Sites. The balance of the camping year we will accept reservations without a minimum day requirement.
5. Reservations can be made for the current calendar year.
6. Park management maintains the authority to assign sites or refuse reservations.
7. Only one camping unit and one tent are permitted on each site.
8. CANCELLATIONS - A \$10 cancellation fee will be assessed for cancellations less than 7 days prior to stay.

Rules

Quiet hours 11pm-8am. No ORVs, generators, or loud activity will be permitted during that time.

No Fireworks allowed

ORVs are only to be ridden on marked trails. ***No ORVs on grassy areas.***

Playground is open dawn to dusk.

All sites must be paid in advance.

Only one camping unit and 1 tent allowed per site.

All children must be accompanied to the bathroom/showers by an adult.

Dogs and other pets are welcome at the park but must remain on a leash and never left unattended.

Please clean up after your pet.

No cutting of standing trees

Fires are permitted in fire pits and grills only. No open burning. ***No burning of trash, construction materials or anything other than firewood.***

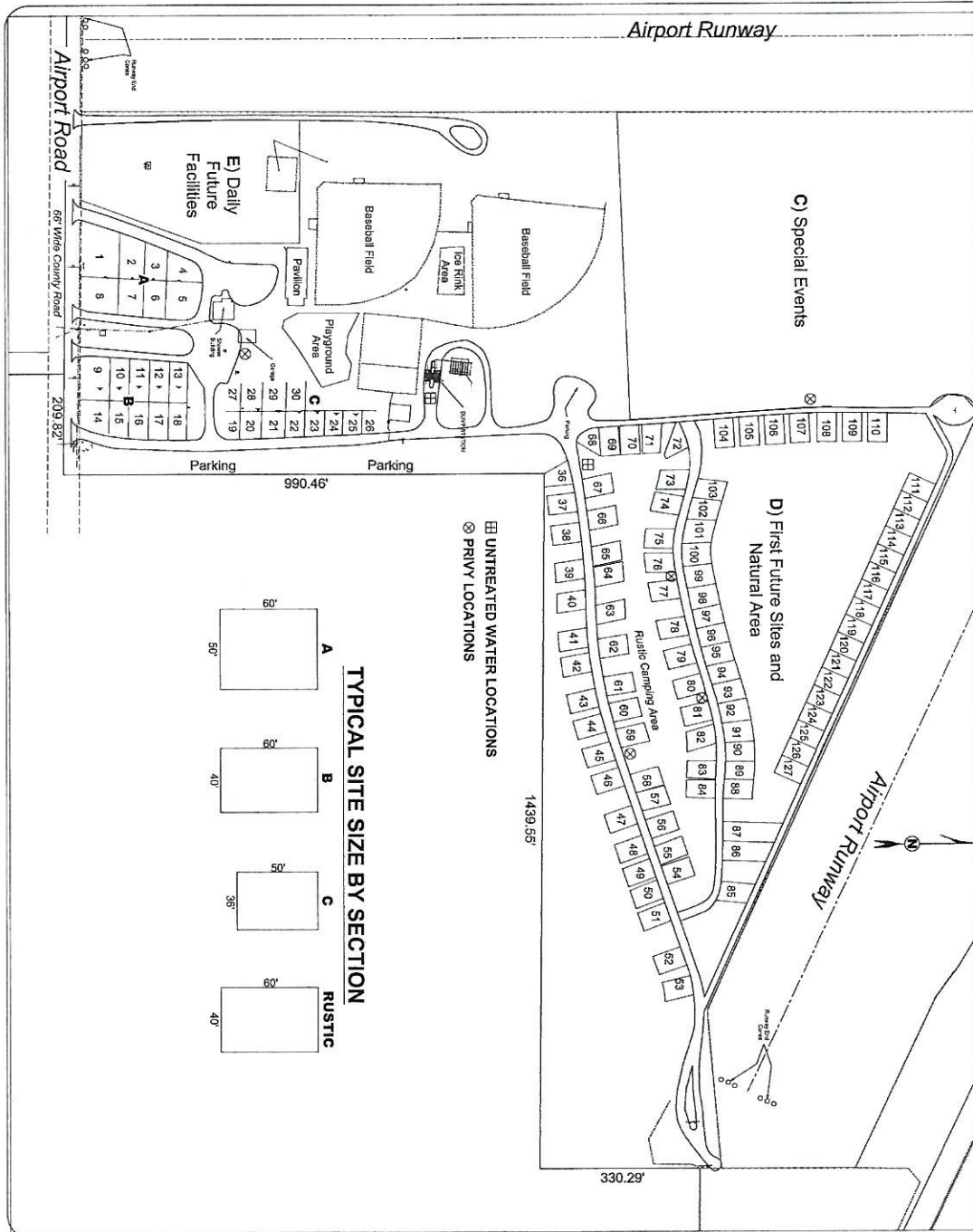
Dump trash only in designated garbage containers.
